Keynote speaker, Mark Turcotte, Ojibwe poet, was born April 5, 1958 and spent his earliest years on North Dakota's Turtle



Mountain Chippewa Reservation and in the migrant camps of the western United States. Later, he grew up in and around Lansing, MI. After leaving school he traveled the country,

working and living on the road for nearly fifteen years.

Arriving in Chicago in the spring of 1993, Turcotte rediscovered his love of words and writing, quickly establishing himself as a unique voice in the city's thriving poetry scene. That summer he was winner of the First Gwendolyn Brooks Open-mic Poetry Award. Soon thereafter he was selected by Ms. Brooks as a Significant Illinois Poet and was named to the Illinois Authors Poster. During the remainder of his time in Chicago he was the recipient of a Writer's Community Residency from National Writer's Voice and was awarded the 1997 Josephine Gates Kelly Memorial Fellowship from the Wordcraft Circle of Native Writers and Storytellers. He left Chicago in early 1998 to live and work in Door County, Wisconsin.

Turcotte is author of *The Feathered Heart*; Songs of Our Ancestors; a chapbook, Road Noise, and Le Chant de la Route, a bilingual selection of his work published in Paris. His latest collection, Exploding Chippewas, is in its third printing. His poetry and fiction have recently appeared in LUNA, TriQuarterly, POETRY, Prairie Schooner, Ploughshares, The Missouri Review, The Seattle Review, Rosebud, Hunger Mountain, North Dakota Quarterly, and The Laurel Review. His poem, The Flower On, was chosen by the Poetry Society of America for inclusion in their Poetry In Motion project, which places poetry placards on public transportation in cities across the United States.

Over the past years Mark has been awarded Literary Fellowships in 1999 and in 2003 by the Wisconsin Arts Board, and was honored with a 2001-2002 Lannan Foundation Completion He Literary Grant. has completed a National Book Foundation American Voices assignment at the Wind River Indian Reservation of Wyoming, and a Lannan Writer's Residency in Marfa, Texas. His work is included in the national high school poetry recitation project, Poetry OutLoud.

After serving as the 2008-09 Visiting Native Writer at the Institute of American Indian Arts in Santa Fe, New Mexico, he has returned to Chicago where he is Visiting Assistant Professor of Creative Writing at DePaul University.

Amy Kindred of Indianapolis, IN, is a painter with paintings in private and public collections across the United States and in Mexico, and a 2005 Creative Renewal Arts



Fellowship winner. Her art work was published in *UU World Magazine*. She is also a writer, theologian, and a former art teacher and arts administrator.

Her essays are included in *Indiana Authors* 2007: Twelve Writers from the Heartland and Indiana Authors 2007: Inspiration from the Heartland, both titles published by New Century Publishing Company. Amy has a Master of Divinity degree, a Master of Theological Studies degree with research in art and religion, was ordained, and is currently serving the First Unitarian Universalist Congregation in Terre Haute, Indiana.

Her book, *Twin Muses: Art and Poetry*, was published in 2010 and includes the poetry of several Indiana poets written about the pictures in the book. This combination of the arts is very fascinating.

Paddy Lynn: I was six years old. My first



grade class was doing a holiday program at the local high school. I walked out on stage dressed in a white tutu, carrying an enormous lollipop bigger than my head, when the lights

suddenly flashed and the sound rolled, and Walla! - It was Showtime! From that moment on, the acting bug bit me and there was no stopping me. To this day, I continue to dream and live my passion as actress and storyteller. Not a day goes by that I don't thank God and my lucky stars for the opportunity.

All through my elementary and high school days, I was active in plays, and fascinated with theatre in general. It was no wonder I majored in theatre in college at Illinois State University, where I received my BA.

After finishing college, I joined a theatre group in Evanston, IL, and helped form a children's theatre company that went into schools in the Chicago metropolitan area. I had such a wonderful time sharing a variety of programs with the students that I decided to return to the schools after taking a hiatus to have my second daughter. When I returned, I worked as a substitute teacher and a teacher's aide in the elementary schools. I was actually honing my skills as a storyteller at the time, without being fully aware that I would soon launch into a career as a storyteller.

NFSPS College/University Level Poetry Competition - 2012

All freshmen, sophomore, juniors and seniors of an accredited university or college are eligible to enter the NFSPS College/University Level Poetry Competition. Two students will receive an award of \$500 each, one as the Edna Meudt Memorial Award and the other as the Florence Kahn Memorial Award. Recipients will be selected on the following basis:

- 1. Submission of a completed NFSPS official application that has been duly notarized. This form as well as the rules are found on the nfsps.com website.
- 2. Submission of a manuscript of ten original poems. Send four copies of the manuscript.
- 3. Manuscript must be titled.
- 4. Manuscript must have a cover page with name, address, phone number in upper left corner and the title of the manuscript in center of the page.
- 5. One poem to each page, single-spaced with a title for each poem.
- 6. Each poem must be no more than 46 lines (includes the spaces between stanzas)
- 7. Each poem must have no more than 50 characters per line (includes spaces between words and punctuation).
- 8. No identification on any page other than the cover page.
- 9. A dedication page may be included.
- 10. No illustrations.
- 11. No entry should be mailed prior to January 1, 2012.

Notarized applications and manuscripts must be received on or before February 14, 2012. This means it must be mailed prior to February 14 with sufficient time for your submissions to arrive to the contest chair. First class mail only. No special deliveries. No email submissions. Candidates will be disqualified if any of the above requirements are not followed. Mail complete package to:

Recipients will be selected on or before March 31, 2012 and announced after April 15, 2012. Each recipient's state poetry society will be notified. Award manuscripts will be published by NFSPS, and each recipient will receive 75 copies of the published manuscript in addition to the cash award. Recipients will be invited to read from their work at the 2012 NFSPS Convention to be held in Merrillville, IN, June 14-18. NFSPS will provide an additional \$300 travel stipend to those recipients attending the Convention. Winners are responsible for the balance of costs (room and meals) at the Convention and to make their own reservations.

ENCORE COVER ART CONTEST

NFSPS members are reminded to submit photos or original art work to be considered for the cover of the 2011 Encore that will be presented at the June 2012 convention in Indiana. These photos/artwork may be submitted in hard copy by mail or digitally by e-mail to Encore editor, Valerie Martin Bailey. Send hard copies to 2207 Parhaven Drive, San Antonio, Texas 78232 or by e-mail to vbailey@satx.rr.com. Please write your name, address, phone number, and e-mail address on the back of each photo or include it with your e-mail. Vertical or horizontal layouts will be considered. In horizontal formats, the focal point of the photo must be on the right side of the photo, so it can be used as a wrap cover. A horizontal format will be scaled to 12.5 x 9 and a vertical format will be scaled to 6 x 9. Photos/art do not have to be these exact sizes, as they will be reduced or enlarged to fit. Very small or very large photos may present a problem when reduced or enlarged. Hard copies will need to be scanned and must be no larger than 8.5 x 11 in order to fit the scanner. No photos will be returned unless specifically requested and a suitable envelope with postage is provided. The editor keeps the photos/art on file and they may be used in later years as well as the current year. The deadline for sending submissions is March 1, 2012.

NFSPS NATIONAL CONVENTION POEMS:

Subject is Indiana, any aspect. May be any form, except prose poem, limited to 40 lines. Entry fee is \$10 for up to three poems. First prize is \$100 and second to tenth is \$10 each.

NFSPS NATIONAL CONVENTION INVOCATION

POEMS: Subject is a poem of thanks, appreciation, or inspirational, non-denominational; limited to 20 lines. Entry fee is \$5 per poem, no limit. Six winners will receive \$25 each.

Rules common to both contests:

- 1) No poet may win more than one prize in each contest and must attend convention to win.

- **4.** Each poem must be neatly typed or computer-generated, and have no more than 50 lines. If a poem continues more than one page, staple the pages together. Do not staple the two copies of the poem together. It is suggested that each state representative keep a copy of poems entered.
- **5.** There should be no large or unusual fonts or illustrations. Times New Roman is the suggested font. No font larger than 12 point should be used. Winning poems are scanned for the award anthology and large and/or unusual fonts impede the process.
- **6. Each entrant must make a declaration of originality.** The statement should appear on the bottom of the ID copy only. The form below is acceptable:

I certify that this poem is my original work, and has not been copied in whole or part from any author's poems in print or posted on the Internet. Signed:

- **7. Separate poems into respective divisions.** Within each division separate the ID copy from the anonymous copy meant for judges. Include a cover letter identifying the Manningham (Youth) Chairperson to whom the report on the contests will be mailed.

POETRY ARTICLE Blank Is Not Free!

For several years my Harp-Strings Poetry Journal sponsored the Robert Frost Death of the Hired Man Award. Form: blank verse. Each year the majority of poems received had to be disqualified because they were not blank verse. I would venture that the poets were writing what they thought was "free verse" and thought 'blank" and "free" were interchangeable. They are not. Not all poetry without rhyme is "free verse". The term does not mean without rhyme, nor does it mean just taking prose and chopping it up into irregular lines. Nor is all poetry without rhyme "blank verse" although the term "blank verse" means verse without rhyme.

Blank verse is metered verse, written in accentual-syllabic prosody (syllabic and accents both counted), often written in iambic pentameter. However, Longfellow wrote Evangeline using dactylic hexameter blank verse and Hiawatha in trochaic tetrameter.

Blank verse is not a form of so many lines and so many stanzas: it is written in as many lines as the poet needs. It can be one long poem with no line breaks, or written in paragraphs or in sections. It is an excellent form for the dramatic, meditative, or narrative poem

Browning used it in his book-length poem, The Ring and the Book. Edwin Arlington Robinson used the form in many of his long narratives. William Butler Yeats used it in The Second Coming, while Robert Frost used it powerfully in Death of the Hired Man and in Mending Wall.

Judson Jerome called blank verse "the most malleable of forms in English verse, like basic black, salt in cooking, or, for that matter, the diatonic scale in music." In this he cautioned, "When writing blank verse you want to retain the feeling of poetry, yet avoid any excess which would draw too much attention to the language itself, away from the meaning. Merely breaking lines of prose into lines that look like poetry is obviously not sufficient to provide that feeling. When one reads such lines they still sound like prose."
